INFORMATION TOURISM TAX

The Municipality of Menfi with the City Council resolution n. 74 of the 19.11.2014 has established the tourism tax starting from January 1st 2015.

The tax was established in order to finance expenditures on tourism, including accommodation facilities and their maintenance, upholding of cultural heritage and of the local environment and of corresponding public services.

WHO HAS TO PAY THE TAX? The tax is applied to non-resident overnight stays in Menfi and is due to the facility manager who will issue a receipt.

HOW MUCH DOES THE TAX COST? The tax is due per person and per night up to a maximum of seven (7) consecutive nights even if carried at different accommodations. In case of stays in accommodation facilities in the outdoors, camping and picnic areas for the temporary parking, tax is applied up to a maximum of seven (7) consecutive nights.

WHO IS EXEMPT?

- officially registered residents of the City from Menfi;
- minors up to 12 years;
- those who work in any facility pointed out at the 1st article, 2nd paragraph of the Guidelines for the Tourism Tax
- those who work in any company based in our Municipality;
- the disabled within the meaning of Article 3 of the Law 104/92;
- the coach drivers and tour leaders who provide assistance to groups organized by travel agencies and tourism. The exemption applies to each bus driver and a tour guide for every 25 participants;
- those who take part to educational tours organized by tour operators and travel agencies for promotional purposes;
- journalists representing national and international magazines hosted by the facilities, who are promoting the City of Menfi and their territory (the whole must be accompanied by appropriate documentation)
- volunteers who offer their own service in town, for events organized by the City Council or the Provincial and Regional one or in case of environmental emergencies
- Militaries staying for service requirements
- The organizers of events sponsored by the City of Menfi and guests of the Municipality who take part to those events

The tourism tax is reduced by 30% in the following cases:

- Participants in school trips
- Organizes groups from 25 people

The exemptions indicated at point 3 and 4 should be proved and demonstrated by operators of accommodation facilities.

In order to qualify for exemption, you can fill out the form available at the accommodation reception.
